### Sub: Conduct of Election for the members of Odisha State Dental Council.

As per the provisions of the section 21 (a) and (b) of Chapter III of the Dentists Act 1948 (Act 16 of 1948) and Para 23 to 28 of Chapter II of Orissa Dental Council Rules 1969, the State Government is pleased to make the following notification for election of four members to the Odisha State Dental Council for smooth functioning of the Council.

- 1. The Registrar of the State Dental Council Odisha is hereby declared as the Returning Officer for election of four members from amongst the dentists registered in the State Dental Council, Odisha.
- 2. The Returning Officer shall issue a Notice of election (Form 'A') [Rule 24] appended to this notification, for election of a member or members of the Odisha State Dental Council and shall invite nominations as per Rule 25. The Nominations shall be filed in Form B appended to this notification. The form of voting papers (Form C) and the declaration (Form D) are appended.
- 3. The Last day of filing Nominations shall be 08.02.2023;
- 4. The Period of scrutiny of nomination papers shall be from Dt. 15.02.2023 to Dt. 22.02.2023;
- 5. The date for sending the voting papers under Rule 25 (11) shall be Dt. 01.03.2023;
- 6. The last date of receipt of the voting papers shall be Dt. 15.03.2023;
- 7. The date of counting of the votes shall be 17.03.2023;
- 8. The date and time of declaration of result shall be Dt. 17.03.2023 at 5.00 pm.
