Pursuant to the provisions of the section 21 of Chapter III of the Dentists Act 1948 (Act 16 of 1948), the State Government have been pleased to constitute the State Dental Council, Odisha with the following members:—


1. Director Medical Education and Training Odisha – Ex-Officio Member
2. Registrar, Odisha Council of Medical Registration – Ex-Officio Member
3. Principal, SCB Dental College Cuttack. – Ex-Officio Member
4. Principal, Kalinga Institute of Dental Science, Bhubaneswar. – Ex-Officio Member
5. Principal, Institute of Dental Science Bhubaneswar. – Ex-Officio Member
6. Principal, Hi-Tech Dental College Bhubaneswar. – Ex-Officio Member
7. Additional Director, DMET Odisha – Member, Nominated by Government
8. Dr. Ashish Kumar Barik, Associate Professor, SCB Dental College Cuttack – Member, Nominated by Government
9. Dr. Lokanath Garhnayak, Associate Professor, SCB Dental College Cuttack – Member, Nominated by Government
10. Dr. Subash Chandra Raj, Associate Professor SCB Dental College Cuttack - Registrar
11. Four members duly elected from among themselves by the registered dental practitioners of the state (in Part- A) - Member
12. One President and one Vice-President elected by the members of Council from among themselves.

The DMET, Odisha shall be the President of the State Dental Council for a period of five years from the date of this notification as per the provisio of the sub section (1) of section 25, of the Dentists Act 1948.

The term of office and other conditions and functions of the State Dental Council and its members shall be as per the provisions of the Dentists Act, 1948 and the regulations thereunder.
